
# **EQUITY GROWTH FUND**

#### **Fund overview**

The Equity Growth Fund aims to achieve long term capital growth by predominantly investing in a diversified portfolio of local and international equities with an international focus. The Fund will invest at least 70% of its assets in long-term investments consisting of international (non-Maltese) shares, local shares and units in Collective Investment Schemes. The Fund may also invest in debt securities, money market instruments and deposits with banks. The Fund is not expected to have any particular geographical or market-sector focus though this may change according to market conditions. The Fund is actively managed by experienced fund managers combining HSBC's international expertise with its local knowledge of the Maltese market. The Fund is daily dealing and offers an accumulator class of shares, subject to an initial minimum investment/minimum holding of €1,000.
