
MALTA BOND FUND

Fund overview

The Malta Bond Fund aims to maximise returns by investing in Maltese debt securities and (to a lesser extent) non-Maltese debt securities. The Fund invests in Maltese debt securities listed on the Malta Stock Exchange and/or debt securities issued (and/or guaranteed) by entities located, registered, or incorporated in Malta. The Fund may also invest in money-market instruments, deposits with banks and other UCITS or other collective investment schemes. A maximum of 15% of the total assets of the Fund may be invested in non-Maltese assets. The Fund has obtained a derogation from the MFSA to be able to invest in excess of 35% of its assets in Transferable Securities and/ or Money Market Instruments issued by the Government of Malta. The Fund is actively managed by experienced fund managers combining HSBC's international expertise with its local knowledge of the Maltese market. The Fund is daily dealing and offers an income class of shares with no minimum investment requirement. The income class of shares of the Fund aims to provide investors with regular dividend payments. The frequency of payments is not guaranteed and may vary from time to time.


