

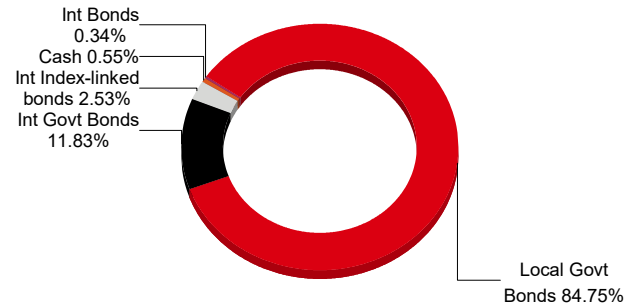

Fund overview

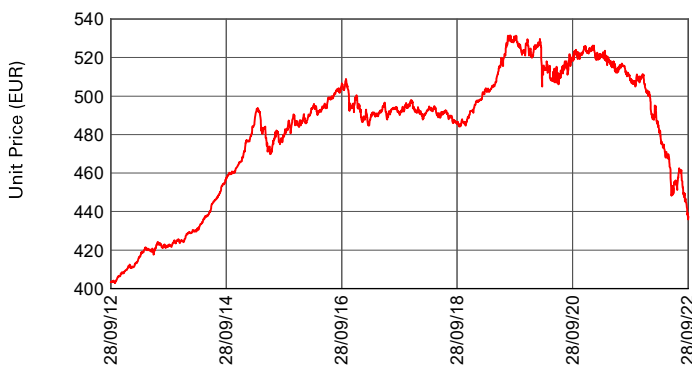
The Malta Government Bond Fund aims to maximise returns by investing in Malta Government Securities and (to a lesser extent) International Government (and related entities) debt securities. The Fund's assets will mainly consist of debt securities and money market instruments issued and/or guaranteed by the Maltese Government including its agencies. The Fund may also invest in deposits with banks licensed in Malta. A maximum of 15% of the total assets of the Fund may also be invested in non-Maltese assets. The Fund has obtained a derogation from the MFSA to be able to invest in excess of 35% of its net assets in Transferable Securities and/ or Money Market Instruments issued by the Government of Malta. The Fund is not a capital protected product. The Fund is actively managed by experienced fund managers combining HSBC's international expertise with its local knowledge of the Maltese market with the aim of seeking to achieve the objective whilst attempting to preserve capital. The Fund is daily dealing and offers an accumulator class of shares, subject to an initial minimum investment/minimum holding of €1,000.
