Objectives and Investment Policy

- The Fund aims to provide long term capital growth and income by investing in a portfolio of corporate bonds that has a lower carbon intensity compared to its reference benchmark. Carbon intensity is calculated as a weighted average of the carbon intensities of the Fund's investments.
- In normal market conditions, the Fund will invest at least 70% of its assets in investment grade, non-investment grade bonds, and other similar securities issued by companies based in developed markets and emerging markets. The Fund will invest in bonds issued by companies with consideration of their Lower Carbon Criteria.
- Lower Carbon Criteria may include but are not limited to: exclusion of companies with a carbon intensity above the weighted average of the constituents of the reference benchmark; exclusion of companies with high carbon intensity relative to their sector; and exclusion of companies with insufficient data to establish their carbon intensity.
- The Fund will also invest in Green Bonds (debt securities whose proceeds are invested in projects with climate or other environmental sustainability purposes), meeting the Green Bond Principles of the International Capital Market Association. Such Green Bonds are not subject to the Lower Carbon Criteria.
- The Fund will not invest in companies involved in the production of tobacco or related activities.
- The Fund invests mostly in bonds which are denominated in US dollars (USD). The Fund may have exposure to non-USD currencies, including emerging markets local currencies that are hedged back to USD. Normally the Fund's exposure to non-USD currencies will be limited to 10% of its assets.
- The Fund may invest up to 10% of its assets in onshore Chinese bonds through the China Interbank Bond Market (CIBM).
- The Fund may invest up to 10% of its assets in non-investment grade bonds.
- The Fund may invest up to 10% of its assets in asset-backed securities (ABS) and mortgage-backed securities (MBS). ABS and MBS are types of debt securities the repayments of which come from loans or mortgages.
- The Fund may invest up to 10% of its assets in contingent convertible securities (CoCos). However, this exposure is not expected to exceed 5%.
- The Fund may invest up to 10% of its assets in other funds, including other funds of HSBC Global Investment funds.
- The Fund may enter into securities lending transactions for up to 29% of its assets. However, this is not expected to exceed 25%.
- The Fund may also invest in derivatives for hedging, cash flow management and investment purposes. Derivatives will not be used extensively for investment purposes. Derivatives may be embedded in other instruments used by the Fund.
- Currency hedging is carried out in respect of the share class. The aim is to protect against exchange rate fluctuations between the share class currency EUR and the base currency of the Fund USD.
- The reference benchmark, shown in the past performance section, does not take account of currency hedging. There may be a greater difference between the past performance of the share class and the reference benchmark than for other share classes in the Fund.
- The Fund is actively managed and does not track a benchmark. The reference benchmark for the Fund is Bloomberg Barclays Global Aggregate Corporates Diversified Hedged USD.
- The Investment Advisor will use its discretion to invest in securities not included in the reference benchmark based on active investment management strategies and specific investment opportunities. It is foreseen that a significant percentage of the Fund's investments will be components of the reference benchmark. However, their weightings may deviate materially from those of the reference benchmark.
- The deviation of the Fund's performance relative to the benchmark is also monitored, but not constrained, to a defined range.
- Income is reinvested.
- You may sell your investment on most working days.
- Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within a period of 5 years.

Why is this Fund in this specific category?

This Fund is classified in category 4 because its price or simulated data has shown medium fluctuations historically.

Material risks not fully captured by the Risk and Reward Indicator:

- Counterparty Risk** The possibility that the counterparty to a transaction may be unwilling or unable to meet its obligations.
- Credit Risk** A bond or money market security could lose value if the issuer's financial health deteriorates.

- Default Risk** The issuers of certain bonds could become unwilling or unable to make payments on their bonds.
- Derivatives Risk** Derivatives can behave unexpectedly. The pricing and volatility of many derivatives may diverge from strictly reflecting the pricing or volatility of their underlying reference(s), instrument or asset.
- Emerging Markets Risk** Emerging markets are less established, and often more volatile, than developed markets and involve higher risks, particularly market, liquidity and currency risks.
- Exchange Rate Risk** Changes in currency exchange rates could reduce or increase investment gains or investment losses, in some cases significantly.
- Interest Rate Risk** When interest rates rise, bond values generally fall. This risk is generally greater the longer the maturity of a bond investment and the higher its credit quality.
- Investment Leverage Risk** Investment Leverage occurs when the economic exposure is greater than the amount invested, such as when derivatives are used. A Fund that employs leverage may experience greater gains and/or losses due to the amplification effect from a movement in the price of the reference source.
- Liquidity Risk** Liquidity Risk is the risk that a Fund may encounter difficulties meeting its obligations in respect of financial liabilities that are settled by delivering cash or other financial assets, thereby compromising existing or remaining investors.
- Operational Risk** Operational risks may subject the Fund to errors affecting transactions, valuation, accounting, and financial reporting, among other things.

Charges

The charges you pay are used to pay the running costs of the Fund, including the marketing and distribution costs. These charges reduce the potential growth of the investment.

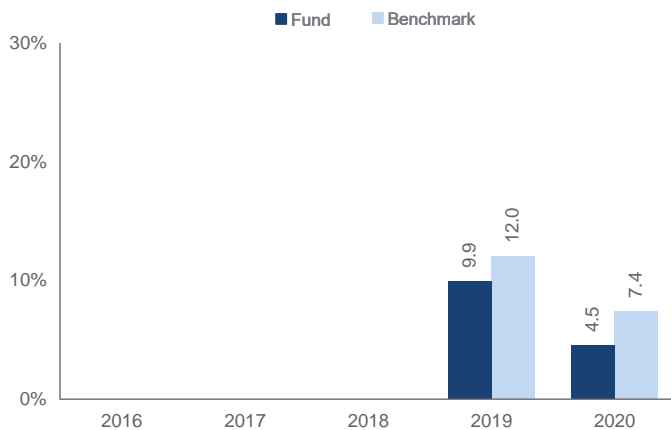
