## Objectives and Investment Policy

- The aim is to provide a combination of growth and income within a medium to high risk investment strategy.
- The Fund will invest in accordance with a medium to high risk investment strategy as determined by the Fund's investment manager.
- In normal market conditions, the Fund will invest at least 90% of its assets in bonds, shares and other assets classes such as real estate, private equity and commodities. Exposures will be gained directly through markets or other funds. Exposures to other asset classes may also be gained through investments in shares issued by companies based anywhere in the world.
- Up to 100% of the Fund may be invested in or gain exposure to shares of companies. Investment in or exposure to bonds will be up to 50% of the Fund.
- The Fund may invest directly or through funds. Usually between 50% and 100% of investment will be through funds. Where funds are used they may include those operated or managed by HSBC.
- The Fund may invest or gain exposure to bonds of companies, governments and government agencies. Investment in bonds issued by a single government or government-backed agency which has a higher credit risk rating will be limited to 10%.
- The Fund may invest up to 20% of its assets in non-investment grade and unrated bonds.
- The Fund may gain exposure of up to 35% to alternative asset classes and strategies. Alternative asset classes include real estate, private equity and commodities. Exposure to alternative strategies is gained by investing in funds that use derivatives or absolute return strategies. Funds that use absolute return strategies aim to provide a positive return over a particular period.
- The Fund may use derivatives to achieve the investment objective of the Fund and for efficient portfolio management. Derivatives are contracts which have a value linked to the price of other assets. It is not intended that derivatives will be used extensively and their main use will be for hedging risk, cash flow management and tactical asset allocation.
- The Fund's main currency exposure will be to US dollars.
- The reference currency of the Fund is USD. The reference currency of this share class is USD.
- The Fund is actively managed and is not constrained by a benchmark.
- Income is reinvested.
- You may sell your investment on most working days.
- Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within a period of 5 years.

### Why is this Fund in this specific category?

This Fund is classified in category 5 because its price or simulated data has shown medium to high fluctuations historically.

### Material risks not fully captured by the Risk and Reward Indicator:

- **Counterparty Risk** The possibility that the counterparty to a transaction may be unwilling or unable to meet its obligations.
- **Credit Risk** A bond or money market security could lose value if the issuer's financial health deteriorates.
- **Default Risk** The issuers of certain bonds could become unwilling or unable to make payments on their bonds.
- **Derivatives Risk** Derivatives can behave unexpectedly. The pricing and volatility of many derivatives may diverge from strictly reflecting the pricing or volatility of their underlying reference(s), instrument or asset.
- **Emerging Markets Risk** Emerging markets are less established, and often more volatile, than developed markets and involve higher risks, particularly market, liquidity and currency risks.
- **Exchange Rate Risk** Changes in currency exchange rates could reduce or increase investment gains or investment losses, in some cases significantly.

- **Liquidity Risk** Liquidity Risk is the risk that a Fund may encounter difficulties meeting its obligations in respect of financial liabilities that are settled by delivering cash or other financial assets, thereby compromising existing or remaining investors.
- **Operational Risk** Operational risks may subject the Fund to errors affecting transactions, valuation, accounting, and financial reporting, among other things.

## Charges

The charges you pay are used to pay the running costs of the Fund, including the marketing and distribution costs. These charges reduce the potential growth of the investment.

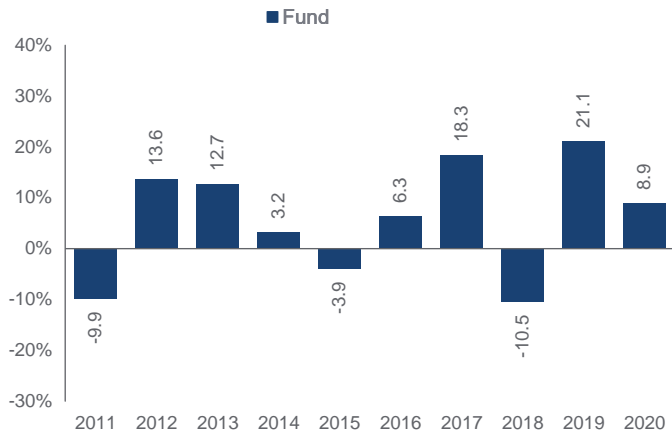
